# Arkansas Community Foundation offers flexible fund types depending on the impact and involvement you want to have:

## DONOR ADVISED

Direct grants to nonprofits of your choosing as you wish (or name other advisors to do so.) Ideal if you who want a hands-on approach or wish to involve family in decision-making.

## DESIGNATED

Specify particular charities to fund on an ongoing basis. Ideal if you want to continually support your favorite nonprofits.

## SCHOLARSHIP

Support students seeking higher education. Ideal if you want to support individual students and allow the Community Foundation (or an educational institution) to select recipients based on your criteria.

## FIELD OF INTEREST

Impact a variety of programs within a particular charitable field—education, animal welfare, hunger, etc.—while allowing the Community Foundation to direct grants within the parameters provided. Ideal if you want to make a deep impact in a specific area.

## FOUNDATION-DIRECTED

Help meet the changing needs of a community while allowing the Community Foundation to direct grants to the most pressing needs. Ideal if you want to support the community at large.

### ORGANIZATIONAL

Similar to a designated fund, an organizational fund/endowment supports a particular nonprofit organization. However, this type of fund is set up by the organization itself to benefit its own operations.
